1. 目的 Purpose

2. 適用範圍.Scope

適用於擬向亞瑞仕國際驗證有限公司管理系統驗證的各驗證申請組織 (中國地區)。

This document is applicable to the application which has applied for management system assessment.(China)

3.稽核收費明細與依據 Assessment fee and criteria

3.1 下述單一系統驗證總費用由申請費、稽核費、註冊費、年度管理費構成，將在 **ARES-FM-03** 《驗證合約書》中明細其具體分配構成。 Following single management system assessment fee consists application fee, assessment fee, registration fee and annual surveillance fee. It is defined clearly in the certification agreement **ARES-FM-03**

4.稽核收費原則 (業務部門可視實際情況進行費用調整) Assessment fee principle(business department can adjust according to the situation)

4.1 大陸地區收費原則 (單位：人民幣)

申請費：1000 人民幣/(初次稽核時及重新驗證時收取)

Application fee: 1000 RMB /charge when initial assessment or re-assessment per three years

稽核費：2000 人民幣/每人天，針對 HSPM 項目 3000 人民幣/每人天

Assessment fee: 2000 RMB /per man- day，3000RMB per man-day

註冊費：1000 人民幣/(初次稽核時及重新驗證時收取)

Registration fee: 1000 RMB (charge when initial assessment or re-assessment per three years

年度管理費：2000 元人民幣/每年追查驗證時收取

Annual surveillance fee: 2000 RMB /charge when surveillance assessment

4.2 為方便快捷計算，本機構規定以下費用為單體系的參考價格，實際價格可由業務人員依申請組織實際情況進行適當調整，上下浮動在 35% 區間內，當組織申請人數超過 1175 人後則需依據 4.1 規定的稽核費增加相應的費用。
